

6. Approval to this Order may be made by fax.



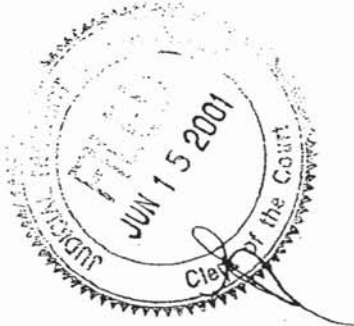
