Dear Mr. Broder;

RE: Your letter to Justice Bielby

Your recent letter to Justice Bielby has been referred to me for response as it is inappropriate for litigants to correspond directly with judges.

The letter that you forwarded to Justice Bielby will not, and cannot, be reviewed by her as the matter is now closed and final, and she has no further jurisdiction to deal with the matter in any way. The Court of Appeal upheld her decision and the Supreme Court of Canada refused to hear your appeal.

I have reviewed the transcript of Master Prowse's comments and they were not intended as instructions to you to ask Justice Bielby to reconsider her decision. Further, he clearly indicated to you that he could not give you legal advice. Neither can I.

Even if his comments could be taken as suggesting that the matter could come back before Justice Bielby, he would have been wrong. Once a judge has issued her decision, it is final and cannot be changed except by an appeal court, and both the Alberta Court of Appeal and the Supreme Court of Canada refused your appeal.


